


This is a short tutorial on how to make a Directory Listing on ONGList.

In this example, we'll register a directory listing for **Brad Inc. Trucking**

## 1) Register a User

Anyone may view ONGList.com, but only registered users may post a listing. This is done to keep the content of the site useful for all users and prevent spam.

Choose **Register** from the menu and complete the simple registration form:
